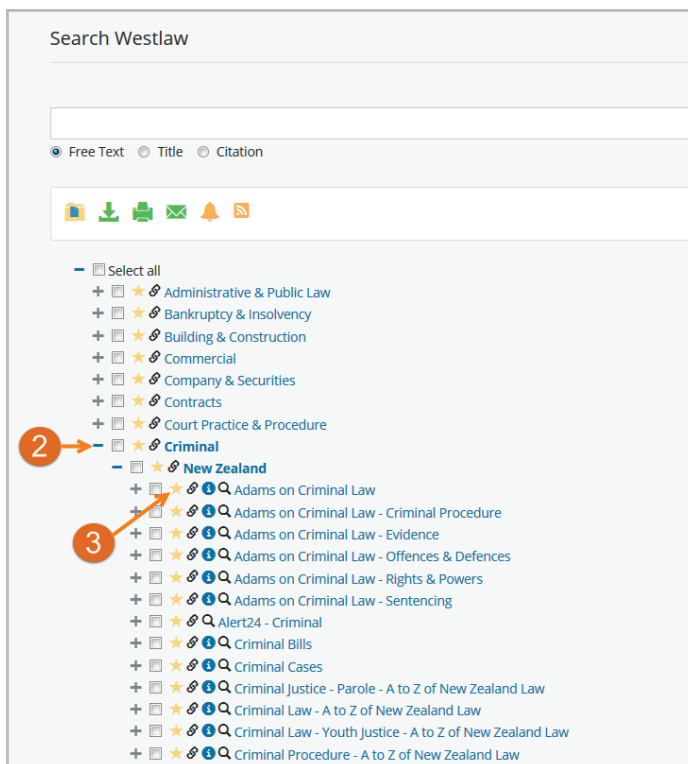
What are Quick Links?

The Quick Links functionality provides Users with the ability to personalise the homepage and create links to regularly accessed content. This includes search forms, products, a chapter, legislation, precedent, case, journals and more. Once a quick link is created a link is displayed on the right hand side of the homepage. Simply click blue star icon  to display a list of deep links.

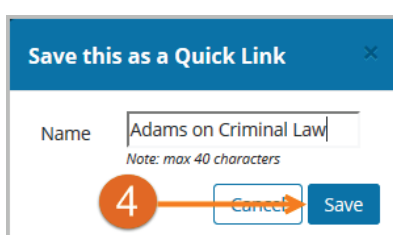
How to Create a Product Quick Link

If you have a OnePass you will be able to create your own quick links. If your organisation has IP access to Westlaw NZ you will need to request Tech Care to create these for your firm.

1. Login to Westlaw NZ <http://www.westlaw.co.nz>
2. Locate the content by browsing the Table of Contents e.g. Adams on Criminal Law.
3. Click on the  yellow star quick link symbol

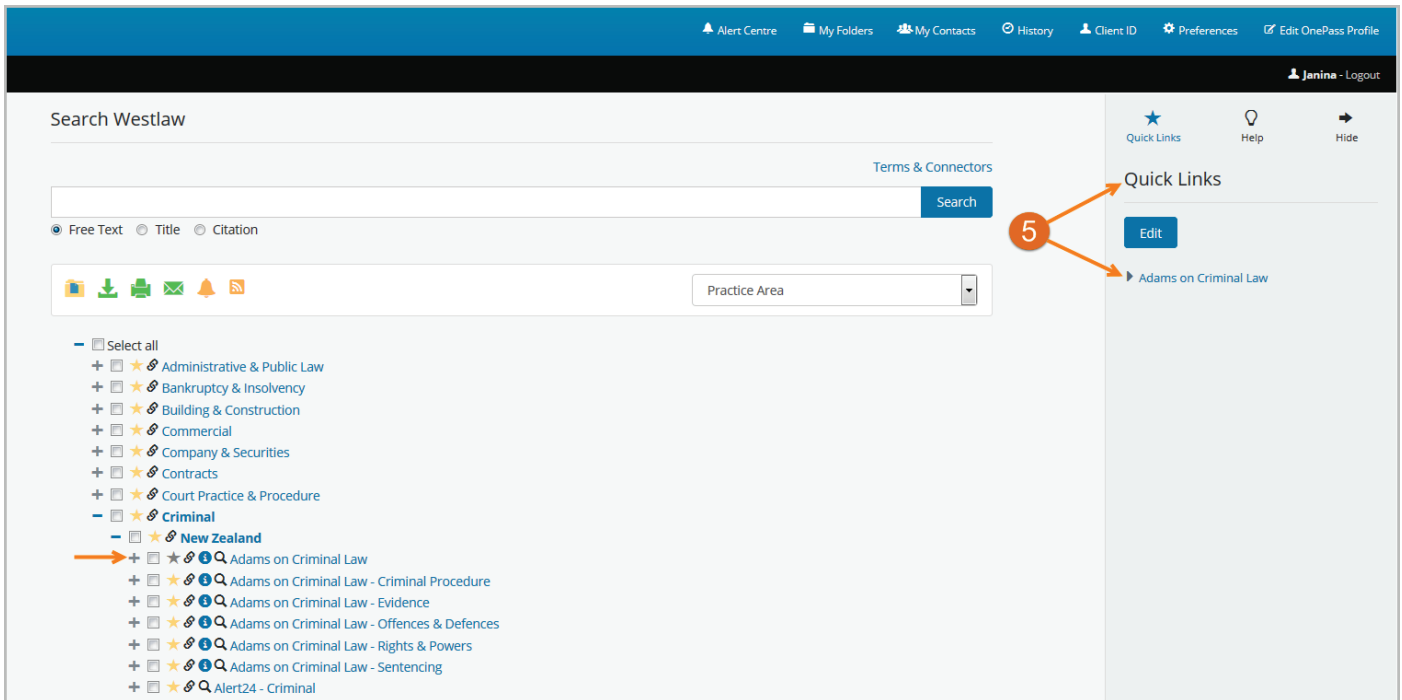


4. Enter a name in the popup window and click **Save** to create the quick link.

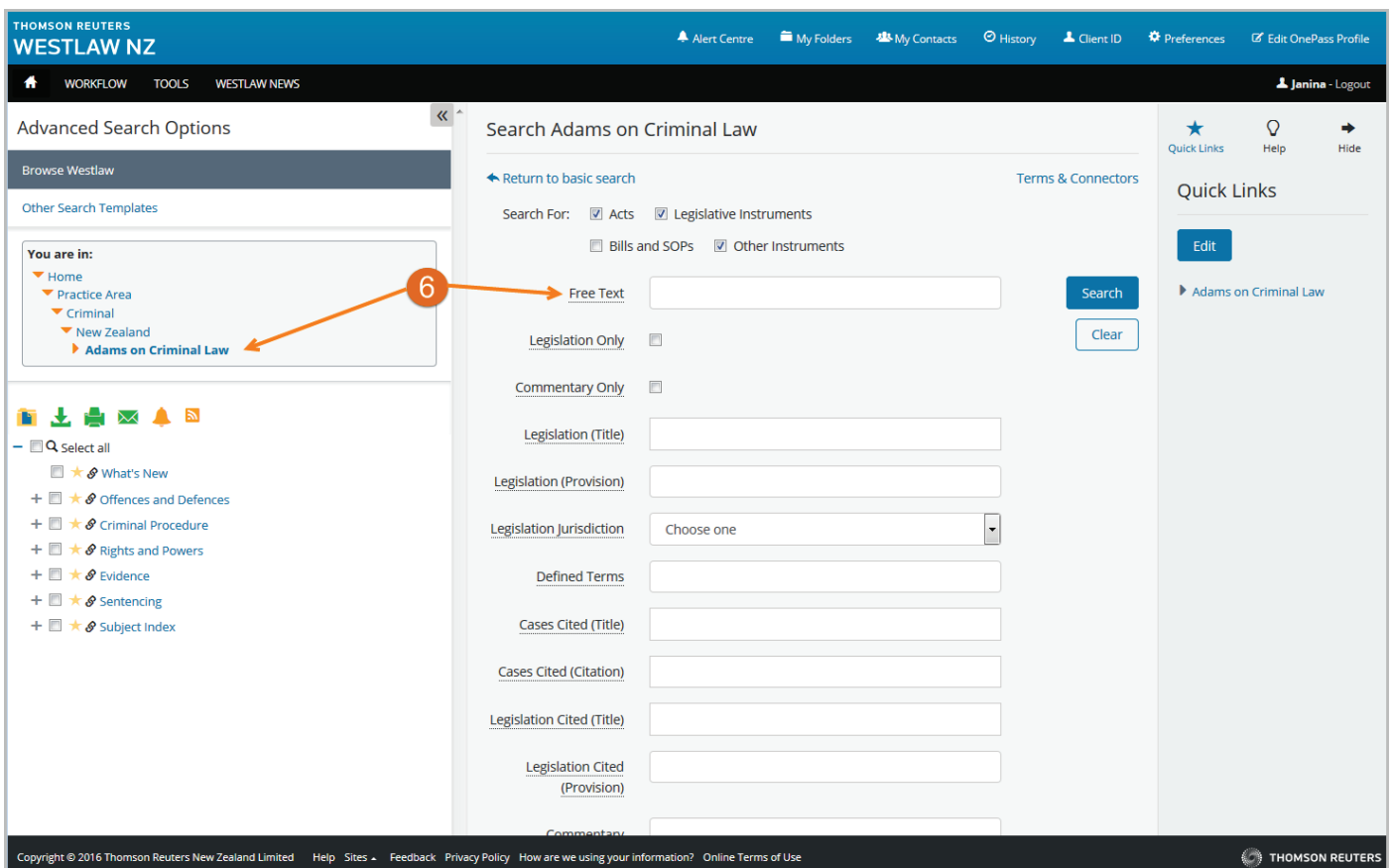


5. The Quick Link will now be added to the **Quick Links list** in the right hand pane.

Note: The yellow star is now a **grey star**  indicating a quick link exists for this product.



6. Click the **Adams on Criminal Law** quick link to display a table of contents in the left pane and a Search Adams on Criminal Law in the right pane. You can now browse and/or search the product.



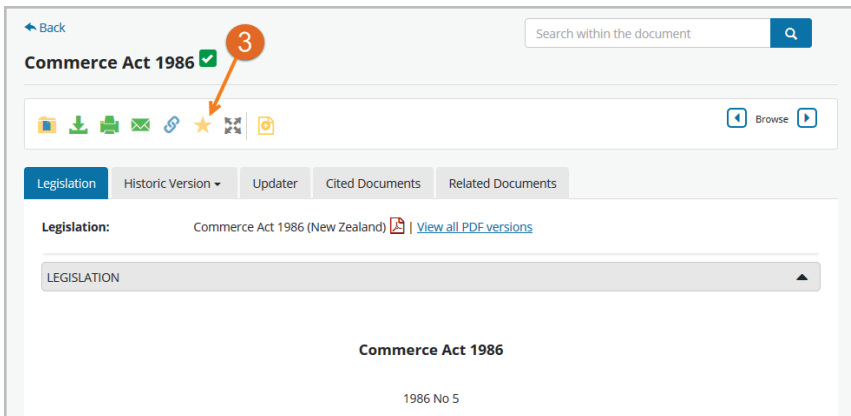
How to Create a Quick Link to the Contents of an Act

Creating quick links to legislation is an efficient method for gaining quick access to an Act or Regulation you research regularly.

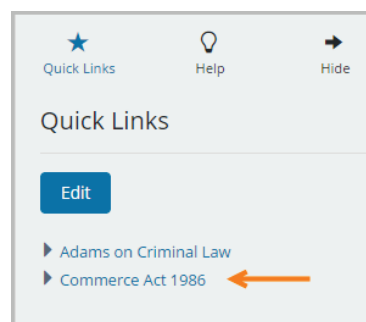
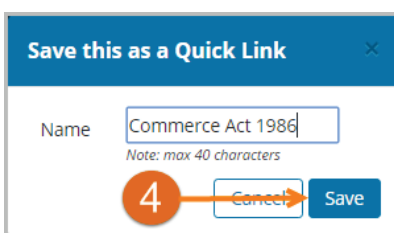
1. You can choose to browse a practice area to locate an Act or Regulation or enter the Act or Regulation name into the basic search box. For example to locate the **Commerce Act 1986** browse the **Commercial** practice area in the Table of Contents to locate the Act title.
2. Click on **Commerce Act 1986** to open and view the Contents Page of the Act.



3. From the Table of Contents page for the Act click the **yellow star** icon at the top of the page.



4. Type in a name e.g. **Commerce Act 1986** and click **Save** to create the quick link.



How to Create a Quick Link to a Case

Creating a quick link to a document such as a case can save you time. It is also useful for gaining access to any notes or annotations you have added to the case.

1. Search for the case by **party names**, citation or topic e.g. **Seales**


How to Edit a Quick Link

2. Click **Edit** to display the quick links page.

3. Click the **pencil**  icon to **edit** the **name** of the quick link.

4. Click the **rubbish bin**  icon to **delete** the quick link.
