FOLDERS



Saving a document in a folder	There is no charge to save a document or text in a folder. Documents and text in a folder may be accessed at no charge for 12 months after the initial chargeable view. In transactional billing sessions, the initial chargeable view occurs the first time a document is viewed (in or out of the folder). Documents viewed in a folder after 12 months will incur the applicable transactional display charge for the document.
Sharing folders within your organization	There is no charge to share a folder. Documents and text in a shared folder may be accessed at no charge for 12 months after the initial chargeable view by any individual within the organization with whom the folder is shared.
Sharing folders across organizations	There is no charge to share a folder with people outside an organization. Outside the organization, an initial chargeable view occurs the first time a document is viewed; it is charged according to the Thomson Reuters Westlaw subscription plan of the person viewing the document. There is no charge for subsequent views within the following 12 months by anyone within an organization with which the folder is shared.
